# CONSISTENCY AND RESILIENCE

Mindy has dedicated an impressive seventeen years as a CASA advocate, and in that time, she's encountered a wide array of challenges faced by families in crisis. Her experience spans a diverse spectrum of individuals—families, caseworkers, judges, and, of course, the 12 children she has served. Yet, one particular case remains etched in her heart.

When Mindy first met this child, they were not yet two years old, entering the foster care system due to substance abuse issues in the home. Over the next eight years, Mindy became a beacon of stability amid an often-tumultuous path that included multiple attempts at reunification with their family.

Monica Carson was the recipient of this year's prestigious Susan Erickson Award for Excellence at Columbia Gorge CASA. Monica has been a steadfast advocate for her CASA youth for three and a half years—an impressive duration that represents over 90% of the youth's time in care. Her unwavering commitment has made a significant impact on the life of this young person, fostering a strong bond built on trust and understanding.

"Monica's creativity and thoughtfulness in her advocacy truly set her apart," said Leah Campbell, Program Coordinator of Columbia Gorge CASA. "She goes above and beyond to engage her youth in new experiences."

Throughout her time with her CASA youth, Monica has demonstrated diligence in her advocacy, consistently submitting detailed reports and maintaining regular monthly visits. CASA staff have had the privilege of witnessing the meaningful relationship between Monica and her youth, characterized by open communication and genuine care. Monica actively listens to her youth's thoughts and concerns, carefully considering how best to support and guide them.

Despite Mindy's cautioning about the risks of premature returns, the child was sent home four times in the hopes of family reunification. Each time, the child's return was followed by yet another heartbreak as they were placed back into care due to relapse. But Mindy never wavered; she was a steadfast support system, always there to advocate for the child's best interests through every challenge.

Initially hesitant to speak up in court, Mindy gradually found her voice, gaining confidence as she realized the importance of her role. With each hearing, she passionately articulated her vision for a brighter future—one where the child could truly thrive.

Finally, after years of ups and downs, the moment of hope arrived: the child was placed in a permanent guardianship with a loving relative. At just nine years old, this child can now look forward to a stable and nurturing home, something they had long dreamed of. Though Mindy must step back from the child's life, she takes comfort in knowing they now have a family that can provide the love and security they need.

Mindy's journey highlights the profound impact a single, dedicated individual can have on a child's life. A Harvard University study underscores the significance of stable relationships, asserting that they are crucial for building resilience in children. Mindy was that rare constant for this child, offering unwavering support and advocacy when it was needed most.

As she reflects on her journey, Mindy finds solace in the fact that she was able to serve as a constant in this child's life when they needed it the most. This child, who experienced so many traumatic changes in their young life, has now finally found permanency with a relative who is able to nurture their growth and healing. This is the essence of why CASA volunteer's matter: they are champions of hope and the enduring support that can change the trajectory of a child's life forever.
